Sliding Scale Tuition Calculator 2025-2026 King Street Cooperative Preschool

<u>Overview</u>: King Street Cooperative Preschool has a sliding scale tuition model. Scholarships are also available. Our goal is to make King Street a welcoming and accessible space for all families. Enrolled families self-select their tuition rate based on their family income. We do not ask families to provide financial information.

For context, Tier 4 is our base tuition rate. King Street created this sliding scale tuition calculator using 2024 data from the Department of Housing and Urban Development for Seattle area median income (AMI). It will be updated annually.

<u>Family size & annual income</u>: Select your tier based on your annual household income and family size. Family size refers to the number of people supported financially by your household income.

<u>Preschool Cohort tuition</u>: Determine your monthly tuition rate based on your tier and the tuition rate of each day your family is enrolled. Tuesday's higher tuition accounts for the smaller class size and lower child:adult ratio. Friday's higher tuition accounts for a longer class session.

<u>Full Preschool Days</u>: Families can also enroll for "full preschool days." These are days that have no classroom co-op responsibility and do not count towards your in-class working ratios. Enrolling for a "full preschool day" costs an additional \$145 per month on top of the regular co-op tuition fee. If you cannot work in the classroom on a certain day of the week (e.g. Mondays), choose this option to ensure you are not scheduled for that day.

<u>Plus One Benefit</u>: In line with our family friendly philosophy, caregivers are able to bring another child preschool age or below with them on their working shift. To keep our child:adult ratio low, a limited number per day is available, so please include this on your application. The table below shows the additional cost per month per day your student is enrolled.
